### **BORROWER'S AGREEMENT – ELECTRONIC READERS**

You are participating in an innovative pilot project by the Town of Surfside to assess the utility of the newest Electronic Readers, to test Town of Surfside ability to circulate handheld technology and meet the literary needs of the Town of Surfside residents. The devices will be available for rental thirty minutes after the Community Center Pool Facility opens and will remain available for rental up to thirty minutes prior to Community Center Pool Facility closing. The e-reader rental availability is subject to availability and the times available for rental are subject to change.

#### **To check out an Electronic Reader, you must:**

- Provide Community Center Staff with two forms of identification;
  - The first form of identification shall be the Town of Surfside Resident ID; and
  - The second form of identification shall be a state issued driver's license, identification, or passport. \* A copy of the photo identification will be kept on file until the e-reader is returned.
- Provide Community Center Staff with a valid credit card, whereby \$1.00 will be held to verify validity. In case of damage or failure to return the e-reader and accessory items the credit card will be charged up to \$250.00 for replacement costs (up to and including costs of accessory replacement).

#### **Upon return of an Electronic Reader, you must:**

- Return e-Reader 60 minutes prior to scheduled Community Center Pool closing time.
- Return e-Reader with all accessory items given at time of rental (plastic case, cover, charging cord, instruction booklet).
- Return e-Reader to Town of Surfside Community Center Facility Front Desk Staff.
- Failure to timely return and or all items in condition received will result in replacement and/or repair charges assessed.

#### **By signing this release you:**

- Agree to return the e-Reader and accessory items in the same condition as it was received.
- Agree to reimburse the Town for all costs and/or purchases made with the e-reader during the rental period.
- Understand that failure to return e-Reader (and/or any accessory items) and failure to reimburse for any purchases or cost associated with the rental will result in having household account blocked (any unpaid debts will be forwarded to a collection agency) and in loss of privilege to

attend Community Center Facility and/or participate Parks and Recreation Department events and activities.

- The electronic readers are not to leave the Community Center premises.
- To pay the replacement and processing fees if e-Reader is not returned or damaged.
- Agrees that any purchases and/or information entered into e-reader is at the user's own risk. The Town is not liable for the protection or security of any information entered into the device.
- Agrees that the use of any devices by a minor is subject to parental consent and guidance.
- The Town bears no responsibility for material available on the e-reader device.
