A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, APPROVING BUDGET AMENDMENT NO. 1 FOR THE FISCAL YEAR 2025 BUDGET; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

- WHEREAS, on September 24, 2024, the Town of Surfside (the "Town") Commission adopted Resolution No. 2024- 3332 approving the budget for Fiscal Year 2025 and establishing revenues and appropriations for the Town; and
- **WHEREAS**, the <u>Capital Projects Fund</u> is being amended to re-appropriate \$5,446,837 of fund balance to carryover capital project balances funded in prior years for Champlain Towers South Memorial Park (\$34,000); 96th Street Park (\$195,125); and Utilities Undergrounding (\$5,217,712); and
- WHEREAS, the Municipal Parking Fund is being amended to re-appropriate \$1,600,000 of Unrestricted Net Position for the purchase of 9333 Harding Avenue; and
- WHEREAS, the Town Commission desires to amend the Fiscal Year 2025 budget by amending the Capital Projects Fund and the Municipal Parking Fund, as set forth in Attachment "A" appended hereto; and
- **WHEREAS**, the Town Commission finds that this Resolution is in the best interest and welfare of the residents of the Town.
- NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:
- <u>Section 1.</u> Recitals. That each of the above-stated recitals are hereby adopted, confirmed, and incorporated herein.
- <u>Section 2. Approving Amended Budget; Budget Amendment No. 1.</u> That the Town Commission approves the 2025 fiscal year budget amendment provided for in Attachment "A" appended hereto.
- <u>Section 3.</u> Implementation. The Town Manager and/or designee are directed to take any and all action necessary to accomplish this Budget Amendment and the purposes of this Resolution.
- <u>Section 4. Effective Date.</u> This Resolution shall take effect immediately upon its adoption.
