- WHEREAS, the Tourist Resort Fund is being amended to appropriate \$31,266 of fund balance, and appropriate \$60,734 of current year reserves to fund Harding Ave. Business District sidewalk sandblasting of \$92,000 per Attachment "A" appended hereto; and
- WHEREAS, the Town Commission desires to amend the Fiscal Year 2025 budget by amending the General Fund and the Tourist Resort Fund, as set forth in Attachment "A" appended hereto; and
- **WHEREAS**, the Town Commission finds that this Resolution is in the best interest and welfare of the residents of the Town.
- NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:
- <u>Section 1.</u> <u>Recitals.</u> That each of the above-stated recitals are hereby adopted, confirmed, and incorporated herein.
- <u>Section 2.</u> Approving Amended Budget; Budget Amendment No. 2. That the Town Commission approves the 2025 fiscal year budget amendment provided for in Attachment "A" appended hereto.
- <u>Section 3.</u> <u>Implementation.</u> The Town Manager and/or designee are directed to take any and all action necessary to accomplish this Budget Amendment and the purposes of this Resolution.
- <u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon its adoption.
