The purpose of this Letter to Commission (LTC) is to transmit the attached Inspections Activity Report for the subject period.

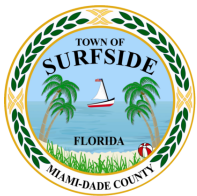
This Report highlights the **63** total inspections performed by inspector as follows:

- *Roofing* by Ulises Fernandez – 4 inspections.

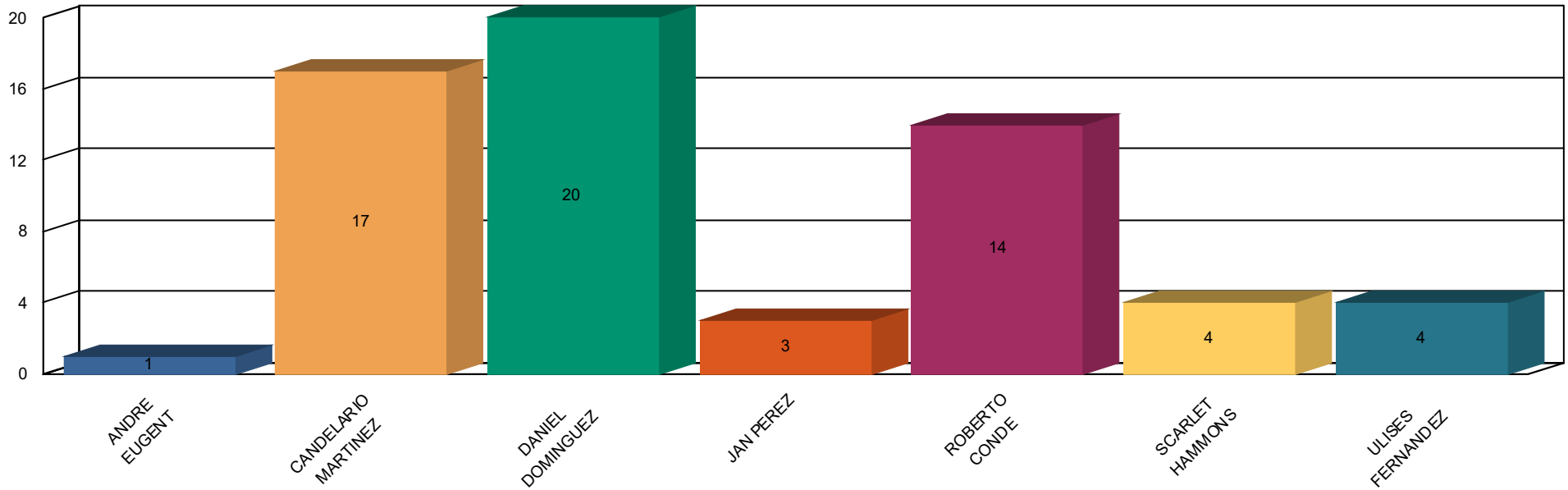
I trust you will find this Report informative and insightful to better understand how our Town Building Department staff serves the Town and its residents and businesses.
